### **Service Fees**

### As of 01/04/2021

We aim to make our service accessible to our community, and do not want cost to be a barrier. **We do not receive external funding. Our fees are necessary to continue to operate as a service**. Should you need to access support, but are in significant financial distress, please let us know and we can discuss this with you. Please note that all session fees below refer to a 50-minute session unless otherwise specified.

#### Cancellation fees:

As FSA Psychology is completely self-funded and receives no external funding, we rely on session payments to continue to operate. When you book an appointment with our service, the psychologist reserves the allotted time especially for you. Non-attendance and cancellations cost our service and are a missed opportunity to have granted the allocated time to another client on the waiting list.

The cancellation fee process differs depending on whether you are attending a therapy or assessment appointment.

- Therapy: If you do not provide 24 hours' cancellation\_notice, your card will be charged 50% of the scheduled fee. If you do not attend your appointment, your card will be charged 100% of the scheduled fee.
- Assessment: You will make a \$100 non-refundable deposit when attending your first assessment session
  onsite. This deposit will contribute to your overall assessment fee should you attend all subsequent
  appointments or provide more than 24 hours' cancellation notice. However, if you do not provide 24 hours'
  cancellation notice or do not attend subsequent appointments, the \$100 will be forfeited and be in excess
  of the overall assessment fee.
